A Past Master of Irvine Valley Lodge No. 671, Irvine as the Grand Treasurer

Very Worshipful Brother Arthur L Salazar Jr. is completing his second term as Grand Treasurer. In this capacity he has been serving as Treasurer of our constitutional boards: Acacia Creek, Masonic Homes of California, California Masonic Foundation, California Masonic Memorial Temple, and Nob Hill Masonic Center.
