Hall Association Update

By the time you read this, our new shed will have been installed, along with a new door lock security system which will give us greater control of access to our Lodge. We'll be deciding on shelving for the shed and then finally trying to



schedule a workday to get our Lodge cleaned up. Once again, Brother Korwin came to our rescue and got our chair lift working.

Last month, I promised to provide you with an explanation of the relationship between our Masonic Lodge (AFL#480) and our Hall Association (Acalanes Masonic Building Association). They are two separate entities, but obviously have close ties. Both are governed by the regulations and ordinances laid down in the California Masonic Code (CMC). Each has separate bylaws. Each has its own state and federal tax exemption status, tax ID codes, and separate tax filing requirements.

Only members in good standing may serve as a hall director. We have nine (9) directors (staggered terms) who are nominated for their position and voted on by the membership at a stated meeting. The Master and Senior Warden are automatically directors of the Hall Association and do not need to be specifically appointed. A term is usually three years, and a member can serve an additional three year term, but must sit out at least one year before being able to again serve as a director. The Hall Association is responsible for repair, maintenance, and improvement of the hall. The Hall Association "pays the bills" - PG&E, phone, garbage pick-up, custodian cleaning, etc. The Hall Association manages all rentals of our facility. Rental income, and any other income, provide funds for the maintenance of the Lodge.

There is strict governance and accounting of those funds. The Hall Association has a signed agreement with the Lodge describing how this rental income must be distributed to the Lodge. The CMC allows the Hall Association to keep up to three months of operating expenses on hand. Anything above that is returned to the Lodge, which keeps a portion in the Special Projects Fund. If the Hall Association has insufficient funds on hand to cover an expense such as major repairs, improvements, etc., a formal request is made during a Stated Meeting for a fund transfer from the Special Projects Fund to the Hall Association. Lodge members vote on these requests at the meeting.

Both the Lodge and the Hall Association are required to conduct annual audits, which are reviewed by our District Inspector and then filed with Grand Lodge. Under the CMC, both, twice a year, are required to report assets, liabilities, income, and expenses during a stated meeting.

We enjoy the service we provide to the Lodge and its membership. We take our duties seriously and try our best to be good stewards of the facility and its financial management.
